

The Beaver Homes & Cottages Win a Toyota Highlander Contest

This contest is open to residents of Canada; and who have reached the age of majority in the province or territory in which they reside and hold a valid provincial driver's license for the operation of an automobile on or before the Contest Closing Date. Other than as noted above, this contest is not open to the employees and representatives of Home Hardware Stores Limited ("Sponsor" or "HHSL"), Toyota Canada Inc. ("Toyota"), their agents, dealers, parent, affiliated or related companies, partners, or subsidiaries; as well as any person living in the same household as such persons, and RESIDENTS OF QUEBEC or residents of any other jurisdiction where this contest is prohibited by law or requires registration or licensing. Toyota is not a sponsor or co-sponsor of this contest.

There will be a total of one (1) Grand Prize awarded.

a. With Purchase: During the Contest Period, visit any participating Home Building Centre or Home Hardware Building Centre dealer ("Dealer") across Canada (excluding Quebec) and purchase any Beaver Homes & Cottages materials package ("Package"). PRIZE:

Sponsor is not responsible for any difference in the Anticipated MSRP and the final MSRP. Prize includes MSRP, Freight & PDI and all applicable fees and taxes.
